The following students have been selected/provisionally allotted hostel accommodation under the 2nd Hostel Allotment List

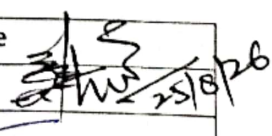

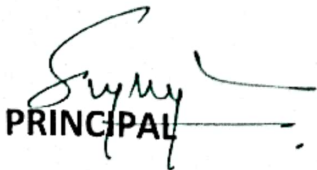

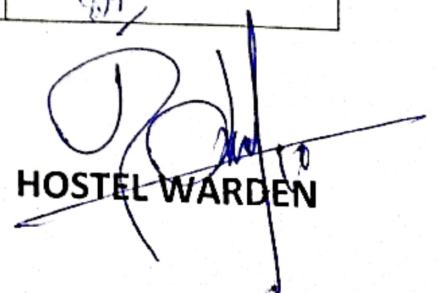

AFFIDAVIT
(For Good Conduct and Discipline in Hostel)

I, Mr. _____, son of Sh. _____, resident of _____, currently a student of _____ Semester, Programme _____ at Maulana Azad Memorial College, and a resident of the Boys Hostel, do hereby solemnly affirm and declare as under:

1. That I have been allotted accommodation in the Boys Hostel of Maulana Azad Memorial College and I shall abide by all the Rules and Regulations of the hostel as framed by the college authorities from time to time.
2. That I shall not indulge in any act of vandalism, breakage, or damage to hostel property, including furniture, fixtures, electrical fittings, doors, windows, walls, or any other property belonging to the hostel or fellow students.
3. That I shall not indulge in any quarrel, fight, physical or verbal altercation, or any act of violence with any fellow student, hostel staff, warden, or any other person within the hostel premises.
4. That I shall not indulge in ragging in any form, nor shall I encourage or support such acts by others, and I am fully aware of the legal consequences of ragging as per applicable law.
5. That I shall not possess, consume, or distribute alcohol, drugs, tobacco, or any other prohibited/intoxicating substance within the hostel premises.
6. That I shall maintain discipline, cleanliness, and decorum in the hostel at all times and shall cooperate with the hostel warden and college administration.
7. That in case I am found guilty of breaking hostel property, causing damage, quarrelling, fighting, or indulging in any act of indiscipline or misconduct mentioned above, the hostel/college authorities shall have full right to take strict disciplinary action against me, including but not limited to fine, suspension, or immediate expulsion/removal from the hostel at any time, without prior notice, and I shall not raise any objection or claim to the contrary.
8. That I shall be personally responsible for any loss or damage caused by me and shall bear the full cost of repair/replacement as assessed by the hostel authorities.
9. That the above statements are true to the best of my knowledge and belief, and nothing material has been concealed therein.

RULES AND REGULATIONS FOR HOSTEL

All the students who are staying in the hostel are required to follow the following rules and regulations of the hostel:

1. Students should not shift room furniture to other place otherwise Rs. 1000/- fine will be imposed.
2. Students are neither allowed to use private electrical equipment.
3. Student should take permission of hostel warden and principal to arrange programs in hostel.
4. Hostel accommodation admission will cancel if college admission is cancelled by student.
5. No student shall leave the hostel without prior permission of the hostel warden.
6. Students are not allowed to use vehicle in hostel premises.
7. Warden from institute can visit any room at any time for checking. If any objectionable material found with students, strict action will be taken against them.
8. With permission of the hostel warden, students can go outside only once in a week (Sunday).
9. A student seeking admission to the hostel shall have to submit another affidavit along with his application for hostel accommodation stating that he is aware of the ragging law. Ragging is strictly prohibited. If anyone is found guilty of directly/indirectly involved in ragging, he will be punished/rusticated/expelled/suspended from the institute.
10. All the students are expected to be in hostel before 8:00 P.M.
11. Students should not write on walls, doors and windows. If found, he has to face consequences. All residents must keep hostel neat and clean.
12. Students are not allowed to stay in the hostel during college hours unless the stay is unavoidable due to illness or any other valid reason.
13. Students should register their names in the entry register while going outside.
14. Smoking, gambling in any form such as playing cards (even without money at stake), consumption of alcohol, and use of drugs and even possession of such things are prohibited. Anyone found indulging in the use of such things will be asked to vacate the hostel.
15. Lights and fans to be switched off when no one is in the room.
16. If any student has to stay out of hostel for the night, he must inform the warden through his parents.
17. Students must follow the mess timings and take food in the respective dining hall strictly. If any student is found taking food inside the room, he will be immediately rusticated from the hostel. Students having any complaints regarding hostel or mess should immediately inform the warden.
18. Any kind of celebration in the hostel premises is not allowed and strict action will be taken against violators.
