

## 1. Preface

Govt. Maulana Azad Memorial College, Jammu takes pride in revealing its historical past. Maharaja Sir Partap Singh announced the opening of "Prince of Wales" college in December 1905 to commemorate the visit of Prince of Wales (The future King George V), which was going to be the only institution of higher learning in the entire Jammu region. The college started functioning from 20<sup>th</sup> April 1907 and initially only the Arts subjects namely English, Mathematics, Philosophy, History, Sanskrit, Persian and Arabic were introduced. Later on science subjects viz. Chemistry, Physics, Geology, Geography and Biosciences were inducted in a phased manner. With the dawn of Independence, the college was renamed as "Govt. Gandhi Memorial College" on 20<sup>th</sup> May, 1948. To meet the demand of growing number of students, the college was bifurcated into Arts and Science Colleges on 20<sup>th</sup> September 1954. Govt. G.M. Arts college was shifted to the present premises on 23<sup>rd</sup> September, 1960 and renamed as Govt. Maulana Azad Memorial College. The college started initially with the Arts subjects but later on science subjects namely Chemistry, Physics, Geology, Geography, Electronics and Statistics were inducted in a phased manner.

Govt. M.A.M College has undertaken the process of assessment and accreditation because of its firm conviction that the Institution has the vision and the necessary infrastructure to march towards excellence.

The college is well poised to make optimum and constructive use of the distinctive characteristics of the institution given as under:-


